

FMCA CHAPTER WAIVER AND RELEASE OF LIABILITY FOR EXPOSURE TO COVID-19

The FMCA Chapter, GMC Dixielanders (hereinafter "Chapter"), is scheduling an event for Chapter members and guests at the location and dates shown above (hereinafter "Rally"). The undersigned individual (hereinafter "Attendee") wishes to attend the Rally and participate in the planned activities. As a condition of attending the Rally, the Attendee acknowledges the warnings, agrees to comply with the requirements set forth, and by signing a release of liability agrees to the following:

1. Adherence to Social Distancing Practices. The undersigned Attendee agrees to comply with mask, social distancing and other Covid-19 protocols as well as any additional Covid-19 requirements from applicable local, state and federal mandates.
2. Prohibitions on Attendance. Attendee acknowledges and agrees that no person may enter or attend the Rally if that person has or has had in the past fourteen (14) days: a cough, fever, shortness of breath, difficulty breathing, flu-like symptoms, gastrointestinal upset, or experienced a loss of taste or smell. Attendee certifies that the Attendee does not have or have had in the past fourteen (14) days any of the above listed symptoms.
3. Assumption of Risk. Regardless of adherence to health department requirements and recommendations, there is a risk of Covid-19 exposure whenever an individual enters a public space, a building with other people, or is in a crowd of individuals. By attending this Rally, the undersigned Attendee is assuming the risk of Covid-19 exposure.
4. Release of Liability. Knowing the foregoing risks, the undersigned Attendee accepts sole responsibility for any exposure to Covid-19 and resulting health conditions that may occur as a result of attendance at the Rally and hereby releases and holds harmless FMCA, the Chapter, and its respective officers, directors and staff from any and all responsibility for illnesses, injuries, sickness, death, or other losses arising in any way from participation in the Rally, and potential exposure to Covid-19. And also acknowledges that the FMC Assist Medical Emergency and Travel Assistance Program does not cover Covid-19.
